

## Transfer Program Guide John Wood Community College (JWCC)

# Associates of Arts in General Studies (AA) to Bachelor of Arts (BA) in Business Administration with Concentrations in Finance, International Business, Management, and Marketing

Completion of the AA degree at JWCC fulfills the Disciplinary Perspectives requirements (Social, Communication, STEM, Humanities and Aesthetic) in The Dialogues (Truman State University's undergraduate core curriculum). Students transferring with an AA are required to complete INDV 3XX The Truman Symposium, INDV 3XX Transfer Seminar, two Writing-Enhanced (WE) courses, a 3-credit JINS course, the Missouri Statute requirement, and to demonstrate elementary proficiency in one foreign language, in addition to the remaining major requirements, required support, and the Bachelor of Arts or Bachelor of Science requirement.

In addition to completing the required courses for the AA degree at JWCC, students intending to transfer to Truman State University are advised to take the courses below as part of their degree program at JWCC.

#### Note on Foreign Language:

All students at Truman State University are required to demonstrate elementary proficiency in one foreign language, which requires up to two semesters to complete. Students pursuing a BA degree are required to demonstrate intermediate proficiency in one foreign language, which requires up to four semesters to complete. All transfer students are recommended to begin their language study as early as possible, to ensure a smooth path to graduation.

encouraged to both seek advising at their home institution and to contact the Truman State University Transfer Programs Coordinator when questions arise.

Completion of the above plan will put a transfer student on pace to complete the B.S. in Accounting at Truman State University in two years, assuming satisfactory academic progress. A student transferring without all of the above courses may require more time to complete the degree.

Access to upper-level courses (numbered 300+) in Truman State University's School of Business requires an application. Students who have completed the above plan, and who maintain a 2.50 overall GPA will be prepared to apply for upper-level courses during their first term (fall or spring) at Truman, and will be able to enroll in upper-level courses in the School of Business during their second semester at Truman.

- 6. Submission of a current resume

In order to graduate with a Bachelor's degree, all students at Truman State University are required to satisfy the following:

- Wellness and Health Requirement
- Completion of a high-impact experience outside of the disciplinary capstone
- A 2.0 minimum cumulative GPA (unless a higher requirement is specified), a 2.0 minimum GPA in all coursework completed at Truman, and a 2.0 major GPA
- 120 total credits
- 40 credits of upper-level courses (courses numbered 300+)
- 45 credits must be completed in residence, 28 of which must immediately precede completion of requirements for the degree, 15 of which must be major requirements
